

Notice to Candidates

The written examination for filling up the vacancies in Dy. General Manager (Telecom Operations)/ Dy. General Manager (Telecom Finance) in Bharat Sanchar Nigam Limited is being conducted on 20th October, 2013 (Sunday) from 10.00 AM to 1.00 PM.

2. Provisional e-Admit Cards and Admit cards based **on the** prima facie information provided by the candidates in the application have been sent to all the eligible candidates at their registered e-mail address on 26.9.2013 and also by registered post at their registered address on 30.9.2013. Those candidates who have not received e-admit cards may download their e-admit cards from BSNL website www.externalexam.bsnl.co.in.

3. The candidature, whose admit cards have been issued for the written test is "**PURELY PROVISIONAL**" pending further detailed scrutiny of fulfilling the eligibility conditions for the post applied for. In case, it is found at any stage or even after joining that the candidate does not fulfill the eligibility criteria as per the advertisement, the candidature of such candidate is liable to be rejected, As stated in the admit card or if any information provided by the candidate is found false or is not in conformity with the eligibility criteria including Qualification, experience & Caste Certificate etc. mentioned in the advertisement, his candidature will be rejected at any stage.

4. Candidates are advised to read the instructions printed on the e-admit cards/admit card properly. Since possession and use of electronic devices such as mobile phone, micro phone or any other associated accessories, calculator, log tables, pager, digital diary, book/notes etc. are strictly prohibited in the examination hall. If any candidate is found to be in possession of any of these devices/documents, his/her candidature is liable to be cancelled. As such the candidate should not bring Mobile phone/Microphone etc. at the examination centre. BSNL/Examination centre shall not be responsible for its safe custody/loss.

5. The details printed on the e-admit card/admit card must be checked by the candidate. In case the e-admit card/admit card mentions some other post/discipline or without photograph/signature then candidate is advised to personally report, one day before the conduct of examination at the Facilitation Counter from 10.00 hrs to 12.00 hrs. with two passport size photographs alongwith documentary evidence/proof so that necessary corrections are made and fresh admit card is issued accordingly. All the candidates who have been issued e-admit cards/admit cards and are appearing for written examination are advised to bring atleast two recent passport size photograph on the date of examination also.

6. A facilitation centre shall also be functional in each of the city of examination to address the concerns of candidates and facilitate other examination related issues. The address of the facilitation centre in each of the city of examination shall be available on the BSNL website. Those candidates who getting his application No. as valid candidate through link available on www.externalexam.bsnl.co.in. but not received e-admit card/ admit card may get their admit cards from the Facilitation Centre which shall be operational on 19.10.2013 from 1000 hrs to 1200 hrs.

7. The candidates, in their own interest, are advised to report at 9.15 am on 20.10.2013 at the examination centre. No late coming is allowed in any case.
