#### I. COMPANY PROFILE

Bharat Sanchar Nigam Ltd. (BSNL) was incorporated in September, 2000 under the Indian Companies Act, 1956 with the objective to take over the business of providing telecom services and network of the erstwhile Department of Telecommunications with effect from 1st October, 2000. The Company is providing Telecom Services throughout the country except Delhi and Mumbai. BSNL is a schedule 'A'/ Miniratna CPSE with the administrative jurisdiction of Department of Telecommunications. The company employed 60104 regular employees (Executives 29750 and Non-executives 30354) as on 31.03.2024.

Its Registered and Corporate offices are at New Delhi.

The authorized and paid up capital of the Company was Rs. 210000 crores and Rs. 85266.82 crores (including Non-Cumulative Preference Share Capital of Rs. 7500 crores) respectively as on March 31, 2024.

The shareholding of the Government of India in the Company is 100%.

#### **II. JOB DESCRIPTION AND RESPONSIBILITIES**

The Chairman and Managing Director of BSNL is the Chief Executive of the Corporation and accountable to its Board of Directos and Government of India.

His/ Her overall responsibility is to manage the company successfully that includes strategy formulation, planning, development and operations of its network, as well as, management of its personnel, finance commercial and marketing activities with emphasis on continuous improvement of company's performance by encouraging performance-oriented work culture within the

organization. He/She is also responsible for achieving its corporate objectives and performance parameters by properly driving the revenue growth from various segments viz. Operations of Consumer Fixed Access, Consumer Mobility and Enterprise Business. Further, his/her job also includes successful execution of Government Projects as well as achieving the objectives of revival package given by the Government of India.

## 3. QUALIFICATION:

The applicant should be Engineering Graduate/ Chartered Accountant/ Cost Accountant/ Post Graduate/ Graduate with MBA/ Post Graduate Diploma in Management from a leading Institute.

## 4. EXPERIENCE:

The applicant should possess cumulative experience/ exposure for at least 5 years during the last ten years in Finance/ Business Development/ Production/ Operations/ Marketing/ Project Management in a large organization of repute.

Experience in Telecommunication Industry is desirable.

b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

## 3. For candidates from SPSE/ Private Sector

a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.

b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.

4. In the above cases, no request for relaxation or otherwise would be entertained.
