2. Scope & Specification of the Work:-

The contractor shall employ worker after police verification .The contractor shall employ worker of decent character, sound health and general abilities to carry out such work. The worker employed shall wear/keep identity card provided by the contractor. The worker employed should be able to read and write the instructions written/printed in Hindi/English.

The BSNL reserves the right to bar worker, employed by the contractor to carryout the works, if there is doubt about his/her integrity, conduct and character, the decision of the BSNL in this regard shall be final and binding on the contractor.

BSNL will have the right to increases or decreases up to 50% of the quantity of units specified in the schedule of requirements without any change in the unit price or other terms and conditions at the time of award of contract.

- (i) <u>Supervision of Work:</u> The successful bidder shall ensure supervision of the work on daily basis. The contact no. of the person deputed for supervision shall be intimated to the designated officer of BBNW BSNL at each location.
- (ii) The services of Up keeping should be continuously available as and when required from 9.30 Hrs to 17:30 Hrs. The contractor shall be responsible for payment of minimum wages (for unskilled category) and other statutory benefits (like EPF/ESI etc.) to personnel /labour employed by him as per various Laws,

Period of Contract:-

The contract is initially for a period of one year and is extendable for a further period of one years on mutual agreement.

Penalty:-

In case of breach of any conditions of the contract and for all types of losses caused by the contractor, Principal General Manager Broadband Networks Bangalore shall be at liberty to make deductions from the bills raised by the contractor up to 10% of the billed amount. In case of any inconvenience/loss caused to O/o principal General Manger Broadband Networks Bangalore on account of any sort of failure on the part of the contractor, penalties as decided by Principal General Manager BB Networks Bangalore shall be levied against the contractor. Deduction/recoveries to this effect shall be made from the bills/ otherwise, with in 3 (Three) weeks of the penalty order.

3. Instructions to Bidders

6. BID FORM

- 8.2 The bid security is required to protect the BSNL against the risk of bidder's conduct, which would warrant the security's forfeiture, pursuant to **Para 8.6**.
- 8.3 A bid not secured in accordance with Para 8.1 & 8.2 shall be rejected by the BSNL as non-responsive at the bid opening stage and returned to the bidder without opening financial bid.
- 8.4 The bid security of the unsuccessful bidder will be discharged/returned as promptly as possible, but not later than 30 days after the expiry of the period of the bid validity prescribed by the BSNL,
- 8.5 The successful bidder's bid security will be discharged upon the bidder's acceptance of the Letter of Intent satisfactorily in accordance with clause **18** and furnishing the performance security.

- 8.6 The bid security may be forfeited:

11 Modification and Withdrawal of Bids

- 11.1 The bidder may modify or withdraw his bid after submission provided that the written notice of the modification or withdrawal is received by the purchaser prior to the deadline prescribed for submission of bids.
- 11.2 The bidder's modification or withdrawal notice shall be prepared sealed, marked and dispatched as required in the case of bid submission. A withdrawal notice may also be sent by FAX but followed by a signed confirmation copy by post not later than the deadline for submission of bids.
- 11.3 Subject to clause 03 of instructions to bidders, no bid shall be modified subsequent to the deadline for submission of bids.

12 BID OPENING AND EVALUATION:

12.1 **Bid Opening**

PGM, BB NOC, BBNW, BG or his representative shall open bids in the presence of bidders or their authorized representatives who wish to be present at the time of opening of bids on 29-08-2018 at 15:00 hrs. Authorization letter to this effect shall be submitted by the bidder before they are allowed to participate in bid opening (Format is given in form-III of section -III).

- 12.2 Bids will be opened in 2 stages (i) Techno-Commercial bid and (ii) Financial bid
- 12.3 As shown the bid is decrypted by the TOC the documents will be opened from the Techno-Commercial bid one by one and same report of TOC will be up loaded in e- portal.
- 12.4 TEC will evaluate Techno commercial bid and the report of TEC will be approved by competent authority. Techno commercial qualified bidders will be informed for financial bid opening schedule and the details of the Techno Commercially qualified bidders will be up loaded on the website www.tenderwizard.com/BSNL.
- **12.5** The financial bid of those bidders who are approved to be techno commercially qualified by the competent authority will be opened by the TOC online as per procedure of the e-tender portal.
- 12.6 The date fixed for opening of bids, if subsequently declared as holiday by the BSNL, the revised date of schedule will be notified. However, in absence of such notification, the bids will be opened on next working day, time and venue remaining unaltered.
- 12.7 Before outright rejection of the Bid by Bid-opening team for non-compliance of any of the provisions the bidder is given opportunity to explain their position, however if the person representing the bidder is not satisfied with the decision of the Bid opening team, he/they can submit the

representation to Bid-opening team immediately but in no case after closing of the tender opening process with full justification quoting specifically the violation of tender conditions if any.

Bid opening team will not return the bids submitted by the bidders on the date of tender opening even if it is liable for rejection and will preserve the bids in sealed cover as submitted, by taking signatures of bidders / representatives of the participating bidder present on the occasion.

13. Clarification on Bids:

To assist in the examination, evaluation and comparison of bids, the Purchaser may, at its discretion ask the bidder for the clarification of its bid. The request for the clarification and the response shall be in writing. However, no post bid clarification at the initiative of the bidder shall be Entertained.

14 Preliminary Evaluation:

- 14.1 BSNL shall evaluate the bids to determine whether they are complete, whether any computational errors have been made, whether required documents have been furnished, whether the documents have been properly signed and whether the bids are generally in order.
- 14.2 Prior to detailed evaluation, BSNL will determine the substantial responsiveness of each bid to the bid document for purpose of these clauses. A substantially responsive bid is one, which confirms to all the terms and conditions of bid documents without material deviation. The BSNL determination of bid's responsiveness shall be based on the contents of the bid itself without recourse to extrinsic evidence. A bid determined as substantially non responsive will be rejected by BSNL and shall not subsequent to the bid opening be made responsive by the bidder by correction of the non-conformity.

14.3 BSNL may waive any minor infirmity or non-conformity or irregularity in a bid which does not constitute a material deviation, provided such waiver does not prejudice or affect the relative ranking of any bidder.

15 EVALUATION

- 15.1 Principal General Manager, Broadband Network, NOC Bangalore or his representative shall evaluate the bids to determine whether they are complete, whether any computational errors have been made whether documents have been properly submitted and whether bids are generally in order.
- If there is a discrepancy between words and figures, the amount in words shall prevail over the amount in figures. PGM, BB NOC, BBNW, BG or his representative, will determine the substantial responsiveness of each bid to the bid document. A substantially responsive bid is one, which confirms to all the terms and conditions of the bid documents without material deviation. A bid determined as substantially non-responsive will be rejected by PGM, BB NOC, BBNW, BG. or his representative.
- PGM, BB NOC, BBNW, BG or his representative shall evaluate in detail and compare the substantially responsive bids and comparison of the responsive bids shall be done on the basis of Net cost to BSNL, the price of the services offered inclusive of all levies and charges as indicated in the price schedule in section IV of the bid document excluding taxes which are creditable to BSNL. The payment to the Employee's, their remunerations as per guidelines of Govt. of Karnataka/Govt. of India, actual/practical expenditure regarding maintenance Taxes to Govt. shall be considered before finalizing the charges.
 - 15.4. L1 shall be decided based on the rates quoted at form-1 of section –IV.
- 15.5. BSNL shall evaluate the bids to determine whether they are complete, whether any computational errors have been made whether documents have been properly signed and whether bids are generally in order.
- **15.6.** Based on evaluation of bids, a short-listing of bids will be carried out, the finalised bids may be verified by the evaluation committee after verification of original documents, if found correct, the rate quoted may be accepted /rejected by the evaluation committee after scrutinising all factors. The same may be recommended to the competent authority for approval.

16. AWARD OF CONTRACT

BSNL shall consider placement of letter of intent to those bidders whose bidds found correct in all respects is acceptable. The bidder shall within 10 days of issue of Letter of Intent, give his acceptance along with performance security in conformity with Form II of Section III of the bid document. The BSNL reserves the right to counter offer price(s) against price(s) quoted by any bidder.

17 **RIGHT TO VARY QUANTITIES**

BSNL reserves the right at the time of award of contract to increase or decrease up to 50% of the tendered area of services specified in the scheduled of requirements without any change in hiring charges of the offered quantity or other terms and conditions. However BSNL shall place order as per the actual requirements only from time to time.

18 SIGNING OF CONTRACT

- 18.1 Signing of Agreement shall constitute the award of for Upkeep services & Allied works (Unskilled) contract on the bidder.
- 18.2 Upon the successful bidder furnishing the Performance Security in pursuant to clause 2.1 of Section II, the BSNL shall discharge the EMD in pursuant to clause-8.3 Section I.

19 **ANNULMENT OF AWARD**

Failure of the successful bidder to comply with the requirement of clause 18 shall constitute sufficient ground for the annulment of the award and forfeiture of the EMD in which event BSNL may make the award to any other bidder at the discretion of BSNL or call for new bids

20. PERIOD OF VALIDITY OF BIDS

8. FORCE MAJEURE

If any time, during the continuance of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reason of any war, or hostility, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions. Strikes, lockouts or act of God (Hereinafter referred to as events) provided notice of happenings, of any such eventuality is given by either party to the other within 21 days from the date of occurrence thereof, neither party shall by reason of such events be entitled to terminate this contract nor shall either party have any claim for damages against the other in respect of such non performance or delay in performance under the contract shall be resumed as soon as practicable after such an event may come to an end or cease to exist, and the decision of BSNL as to whether the supplies have been so resumed or not shall be final and conclusive, provided further that if the performance in whole or part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding 60 days either party may, at his option terminate the contract.

9. ARBITRATION

In the event of any question, dispute or difference arising under the agreement or in connection there with (except as to matter the decision to which is specifically provided under this agreement), the same shall be referred to sole arbitration of the CGM, BBNW, New Delhi. In case his designation is changed or his office is abolished then in such case to the sole arbitration of the officer for the time being entrusted whether in addition to the functions of the CGM, BBNW, New Delhi or by whatever designation such officers may be called (hereinafter referred to as the said officer) and if the CGM. or the said officer is unable or unwilling to act as such, then to the sole arbitration of some other person appointed by the CGM or the said officer. The agreement to appoint an arbitrator will be in accordance with the Arbitration and Conciliation Act, 1996.

The arbitrator may from time to time with the consent of both the parties enlarge the time frame for making and publishing the award. 10. SET OFF
